



**Figure 1.1** Main drivers of climate change. The radiative balance between incoming solar shortwave radiation (SWR) and outgoing longwave radiation (OLR) is influenced by global climate 'drivers'. Natural fluctuations in solar output (solar cycles) can cause changes in the energy balance (through fluctuations in the amount of incoming SWR) (Section 2.3). Human activity changes the emissions of gases and aerosols, which are involved in atmospheric chemical reactions, resulting in modified O<sub>3</sub> and aerosol amounts (Section 2.2). O<sub>3</sub> and aerosol particles absorb, scatter and reflect SWR, changing the energy balance. Some aerosols act as cloud condensation nuclei modifying the properties of cloud droplets and possibly affecting precipitation (Section 7.4). Because cloud interactions with SWR and LWR are large, small changes in the properties of clouds have important implications for the radiative budget (Section 7.4). Anthropogenic changes in GHGs (e.g., CO<sub>2</sub>, CH<sub>4</sub>, N<sub>2</sub>O, O<sub>3</sub>, CFCs) and large aerosols (>2.5 µm in size) modify the amount of outgoing LWR by absorbing outgoing LWR and re-emitting less energy at a lower temperature (Section 2.2). Surface albedo is changed by changes in vegetation or land surface properties, snow or ice cover and ocean colour (Section 2.3). These changes are driven by natural seasonal and diurnal changes (e.g., snow cover), as well as human influence (e.g., changes in vegetation types) (Forster et al., 2007).






#### Long-term Climate Changes and Extremes (from SREX SPM) D. Future Climate Extremes, Impacts, and Disaster Losses

- Confidence in projecting changes in the direction and magnitude of climate extremes depends on many factors, including the type of extreme, the region and season, the amount and quality of observational data, the level of understanding of the underlying processes, and the reliability of their simulation in models.
- Models project substantial warming in temperature extremes by the end of the 21st century. It is virtually certain that increases in the frequency and magnitude of warm daily temperature extremes and decreases in cold extremes will occur in the 21st century at the global scale. It is very likely that the length, frequency, and/or intensity of warm spells or heat waves will increase over most land areas.
- It is *likely* that the frequency of heavy precipitation or the proportion of total rainfall from heavy falls will increase in the 21st century over many areas of the globe.
- Average tropical cyclone maximum wind speed is *likely* to increase, although increases may not occur in all ocean basins. It is *likely* that the global frequency of tropical cyclones will either decrease or remain essentially unchanged.
- There is *medium confidence* that there will be a reduction in the number of extratropical cyclones averaged over each hemisphere. There is *medium confidence* that droughts will intensify in the 21st century in some seasons and areas, due to reduced precipitation and/or increased evapotranspiration.
- Projected precipitation and temperature changes imply possible changes in floods, although overall there is *low confidence* in projections of changes in fluvial floods.
- It is *very likely* that mean sea level rise will contribute to upward trends in extreme coastal high water levels in the future.
- There is *high confidence* that changes in heat waves, glacial retreat, and/or permafrost degradation will affect high mountain phenomena such as slope instabilities, movements of mass, and glacial lake outburst floods.
- There is *low confidence* in projections of changes in large-scale patterns of natural climate variability



### **Overall Summary**


- Human influence on the climate system is clear, and recent anthropogenic emissions of greenhouse gases are the highest in history. Recent climate changes have had widespread impacts on human and natural systems.
- Continued emission of greenhouse gases will cause further warming and long-lasting changes in all components of the climate system, increasing the likelihood of severe, pervasive and irreversible impacts for people and ecosystems. Limiting climate change would require substantial and sustained reductions in greenhouse gas emissions which, together with adaptation, can limit climate change risks.
- Adaptation and mitigation are complementary strategies for reducing and managing the risks of climate change. Substantial emissions reductions over the next few decades can reduce climate risks in the 21st century and beyond, increase prospects for effective adaptation, reduce the costs and challenges of mitigation in the longer term, and contribute to climateresilient pathways for sustainable development.
- Many adaptation and mitigation options can help address climate change, but no single option is sufficient by itself. Effective implementation depends on policies and cooperation at all scales, and can be enhanced through integrated responses that link adaptation and mitigation with other societal objectives.

### **Observed Changes**



- Warming of the climate system is unequivocal, and since the 1950s. many of the observed changes are unprecedented over decades to millennia. The atmosphere and ocean have warmed, the amounts of snow and ice have diminished, and sea level hás risen.
- The total increase between the average of the 1850–1900 period and the 2003– 2012 period is 0.78 [0.72 to 0.85], based on the single longest dataset available.


### Atmospheric GHG Concentrations




The atmospheric concentrations of carbon dioxide, methane, and nitrous oxide have increased to levels unprecedented in at least the last 800,000 years. Carbon dioxide concentrations have increased by 40% since pre-industrial times, primarily from fossil fuel emissions and secondarily from net land use change emissions.


#### Ocean "Acidification"

 The ocean has absorbed about 30% of the emitted anthropogenic 🞖 carbon dioxide, causing ocean acidification, and the pH of ocean surface water has decreased by 0.1.





### **Emissions of GHGs**




Total Annual Anthropogenic GHG Emissions by Gases 1970-2010

Anthropogenic greenhouse gas emissions in 2010 have reached 49  $\pm$  4.5 GtCO2 eq/yr. The ocean has absorbed about 30% of the emitted anthropogenic CO2, causing ocean acidification. About half of the anthropogenic CO2 emissions between 1750 and 2011 have occurred in the last 40 years


### **Drivers of Climate Change**

**Total radiative** forcing is positive, and has led to an uptake of energy by the climate system. The largest contribution to total radiative forcing is caused by the increase in the atmospheric concentration of CO2 since 1750.




**Figure SPM.5** | Radiative forcing estimates in 2011 relative to 1750 and aggregated uncertainties for the main drivers of climate change. Values are global average radiative forcing (RF<sup>14</sup>), partitioned according to the emitted compounds or processes that result in a combination of drivers. The best estimates of the net radiative forcing are shown as black diamonds with corresponding uncertainty intervals; the numerical values are provided on the right of the figure, together with the confidence level in the net forcing (VH – *very high*, H – *high*, M – *medium*, L – *low*, VL – *very low*). Albedo forcing due to black carbon on snow and ice is included in the black carbon aerosol bar. Small forcings due to contrails (0.05 W m<sup>-2</sup>, including contrail induced cirrus), and HFCs, PFCs and SF<sub>6</sub> (total 0.03 W m<sup>-2</sup>) are not shown. ### **Climate Projections**




 Future temperature change projections are based on RCPs (Representative Concentration Pathways).

### Adaptation & Mitigation

- Many adaptation and mitigation options can help address climate change, but no single option is sufficient by itself. Effective implementation depends on policies and cooperation at all scales, and can be enhanced through integrated responses that link adaptation and mitigation with other societal objectives.
- Effective adaptation and mitigation responses will depend on policies and measures across multiple scales: international, regional, national and sub-national. Policies across all scales supporting technology development, diffusion and transfer, as well as finance for responses to climate change, can complement and enhance the effectiveness of policies that directly promote adaptation and mitigation.


## Mitigation

- There are multiple mitigation pathways that are *likely* to limit warming to below 2°C relative to pre-industrial levels. These pathways would require substantial emissions reductions over the next few decades and near zero emissions of CO2 and other long-lived GHGs by the end of the century.
- Implementing such reductions poses substantial technological, economic, social, and institutional challenges, which increase with delays in additional mitigation and if key technologies are not available.
- Mitigation options are available in every major sector. Mitigation can be more cost-effective if using an integrated approach that combines measures to reduce energy use and the GHG intensity of end-use sectors, decarbonize energy supply, reduce net emissions and enhance carbon sinks in landbased sectors.
- Climate change is a threat to sustainable development. Nonetheless, there are many opportunities to link mitigation, adaptation and the pursuit of other societal objectives through integrated responses.

## Nuclear Energy

• WG-III AR5 SPM: "Nuclear energy is a mature low-GHG emission source of baseload power, but its share of global electricity generation has been declining (since 1993). Nuclear energy could make an increasing contribution to low-carbon energy supply, but a variety of barriers and risks exist. Those include: operational risks, and the associated concerns, uranium mining risks, financial and regulatory risks, unresolved waste management issues, nuclear weapon proliferation concerns, and adverse public opinion (robust evidence, high agreement). New fuel cycles and reactor technologies addressing some of these issues are being investigated and progress in research and development has been made concerning safety and waste disposal."

### Climate Mitigation – "Carbon Budget"



- Cumulative emissions of CO2 largely determine global mean surface warming by the late 21st century and beyond.
- Limiting total human-induced warming to less than 2° C relative to the period 1861-1880 with a probability of >66% would require cumulative CO2 emissions from all anthropogenic sources since 1870 to remain below about 2900
   GtCO2 (with a range of 2550-3150
   GtCO2 depending on non-CO2 drivers). About 1900 GtCO28 had already been emitted by 2011.
- The remaining "Carbon Budget" will be used up in 30 years.

### **BRING HOME MESSAGE - 1**

- IPCC Produces synthesis of global science literatures – science relevant but non-policy prescriptive.
- The most recent report, AR5 produced in 2013-2014, states, inter alia:
  - Human influence on the climate system is clear, and recent anthropogenic emissions of greenhouse gases are the highest in history. Recent climate changes have had widespread impacts on human and natural systems.
  - Continued emission of greenhouse gases will cause further warming and long-lasting changes in all components of the climate system, increasing the likelihood of severe, pervasive and irreversible impacts for people and ecosystems.
  - Cumulative emissions of CO2 largely determine global mean surface warming by the late 21st century and beyond.

### Before changing the gear --

- Corporate decision-making requires justification, based on, environmental regulations or other factors that affect economic status (or corporate external images).
- In other words, environment policies can take approaches of (i) "Command and Control" and/or (ii) "Economic Policy Tools".
- In the climate context, (i) international mitigation commitment and its national implementation, and (ii) emission trading (both international and domestic) and carbon pricing (tax or subsidy) are such examples.

# United Nations Framework Convention on Climate Change <u>(UNFCCC)</u>

- UNFCCC text was agreed upon in New York in May 1992, and opened for signature at UNCED in June 1992.
- The Convention entered into force on 21 March 1994.
- Currently, there are 197 Parties (196 States and 1 regional economic integration organization (EU)).
- It is a "framework" agreement, which sets forth the fundamental principles, and provides bases for concrete actions, such as the Kyoto Protocol.
- It contains many fundamental provisions, such as "ultimate objectives" and "common but differentiated responsibilities".

## Kyoto Protocol

- Adopted on 11th December 1997 at COP 3 in Kyoto.
- KP Annex B provides "Quantified emission limitation or reduction commitment" for Annex B Parties, which aims at their overall emissions by at least 5 per cent below 1990 levels in the commitment period, 2008 to 2012.
- To take effect, it required ratification by more than 55 UNFCCC Parties, and more than 55% of CO2 emissions (of 1990) by UNFCCC Annex-I Parties
- The Protocol provides for "Kyoto Mechanisms", which contain Emission Trading, Joint Implementation and Clean Development Mechanism). They are meant to (i) stimulate sustainable development through technology transfer and investment, (ii) help countries with Kyoto commitments to meet their targets by reducing emissions or removing carbon from the atmosphere in other countries in a cost-effective way and (iii) encourage the private sector and developing countries to contribute to emission reduction efforts.

## Backgrounds

- Difference of N-S positions before UNCED (text adopted in May 1992) is reflected in "Common But Differentiated Responsibilities."
- The Kyoto Protocol adopted at COP3 (1997, in Kyoto) contains mitigation responsibilities of Annex I Parties only.
- There are some differences among the G-77&China Group, such as those of BASIC, Least Developed Countries, AOSISs and oil producer countries.
- At COP 13 in Bali, Indonesia (December 2007) COP adopted "Bali Action Plan", which started two track approach AWG-LCA and AWG-KP.

## Towards Climate Actions Beyond 2012

- The First Commitment Period under KP was to end on 31<sup>st</sup> December 2012.
- COP13 (2007) adopted the Bali Action Plan, which referred to, for the first time, actions by developing countries!

## Bali Action Plan (Decision 1/CP.13)

- 1. *Decides* to launch a comprehensive process to enable the full, effective and sustained implementation of the Convention through long-term cooperative action, now, up to and beyond 2012, in order to reach an agreed outcome and adopt a decision at its fifteenth session, by addressing, inter alia:
  - (b) (i) Measurable, reportable and verifiable nationally appropriate mitigation commitments or actions, including quantified emission limitation and reduction objectives, by all developed country Parties, while ensuring the comparability of efforts among them, taking into account differences in their national circumstances;

(ii) Nationally appropriate mitigation actions by developing country Parties in the context of sustainable development, supported and enabled by technology, financing and capacity-building, in a measurable, reportable and verifiable manner

(iii) Policy approaches and positive incentives on issues relating to reducing emissions from deforestation and forest degradation in developing countries; the role of conservation, sustainable management of forests and enhancement of forest carbon stocks in developing countries;

(iv) (Cooperative sectoral approaches and sector-specific actions,)

## COP15 and two AWGs

- From 2008, two parallel extremely difficult negotiations continued - Ad hoc Working Group on Long Term Actions (AWG-LCA) and Ad hoc Working Group on Further Commitments of Annex I Parties under the Kyoto Protocol (AWG-KP)
- Most notable N-S differences were; on the need of coherence between the two AWGs, possibility of agreeing on a new integrated legal instrument covering all Parties, level of ambitions of mitigation targets, and so forth.
- Copenhagen COP15 (where more than 130 Head of States participated) only took note of the Copenhagen agreement – a major failure!

## COP16 and 17

- Cancun COP16 (2010) managed to adopt the Cancun Agreement, but a large number of technical details were left for further negotiations.
- Durban COP17 (2011) dealt with many difficult questions, most notably, contiguous commitment after the end of the First Commitment, level of mitigation targets (of Annex-I Parties), Climate Funding, Technology Development and Transfer.
- Although Russia, Canada and Japan declared that they would not participate in the continued commitment (Annex B of Kyoto Protocol), contiguous extension of Kyoto Commitment was agreed by EU and developing countries. (At the time of COP17, all these opponent countries remained KP party, but Canada later declared that it will leave from KP). US will remain non-KP Party, which means that the extended commitment will cover only 14% of global emissions.

Outcome from COP18/CMP8 (2012, Doha)

# UNFCCC COP21

- Overview
- COP21 Decisions provided fundamental principles and steps till the Paris Agreement takes effect.
- "Paris Agreement" a legal text to be applied to all Parties, but it does not contain mandatory actions such as quantitative mitigation commitments.

## Major elements of COP21 Decision - 1

2. ... the Agreement will be **opened for signature from 22<sup>nd</sup> April** 2016

7. *Decides* to establish the **Ad Hoc Working Group on the Paris Agreement ("APA")** under the same arrangement,

11. Decides that the APA shall hold its sessions starting in 2016 ... and shall prepare draft decisions to be recommended through the **Conference of the Parties to the Conference of the Parties serving as the meeting of the Parties to the Paris Agreement ("CMA")** for consideration and adoption at its first session;

17. Notes with concern that the estimated aggregate greenhouse gas emission levels in 2025 and 2030 resulting from the intended nationally determined contributions do not fall within least-cost 2 °C scenarios but rather lead to a projected level of 55 gigatonnes in 2030, and *also notes* that much greater emission reduction efforts will be required than those associated with the intended nationally determined contributions in order to hold the increase in the global average temperature to below 2 °C above pre-industrial levels by reducing emissions to 40 gigatonnes or to 1.5 °C above preindustrial levels by reducing to a level to be identified in the special report referred to in paragraph 21 below;

## Major elements of COP21 Decision - 2

19. *Requests* the secretariat to update the synthesis report [of INDCs] ... and to make it available by 2 May 2016;

20. Decides to convene a **facilitative dialogue** among Parties **in 2018 to take stock of the collective efforts** of Parties in relation to progress towards the long-term goal referred to in Article 4, paragraph 1, of the Agreement and to inform the preparation of **nationally determined contributions** pursuant to Article 4, paragraph 8, of the Agreement;

21. *Invites* the IPCC to provide a special report in 2018 on the impacts of global warming of 1.5 °C above preindustrial levels and related global greenhouse gas emission pathways; [IPCC decided to prepare such report by 2018.]

## Major elements of COP21 Decisions - 3

22. Invites Parties to communicate their intended nationally determined contribution (**INDC**) no later than when the Party submits its respective instrument of ratification, accession, or approval of the Paris Agreement. If a Party has communicated an INDC prior to joining the Agreement, that Party shall be considered to have satisfied this provision unless that Party decides otherwise

23. Urges those Parties whose INDC pursuant to decision
1/CP.20 contains a time frame up to 2025 to communicate by
2020 a new NDC and to do so every five years thereafter
pursuant to Article 4, paragraph 9, of the Agreement;

24. *Requests* those Parties ... INDC ... contains a time frame up to 2030 to communicate or update by 2020 these contributions and to do so every five years thereafter ... ;

25. *Decides* that Parties shall submit ... their nationally determined contributions (NDCs) referred to in Article 4 of the Agreement at least 9 to 12 months in advance of [CPA].

26. *Requests* the ADP to develop further guidance on features of [NDCs]

# Paris Agreement Articles

## Paris Agreement Article 2. (Purpose)

1. This Agreement, in enhancing the implementation of the Convention, including its objective, aims to strengthen the global response to the threat of climate change, in the context of sustainable development and efforts to eradicate poverty, including by:

(a) Holding the increase in the global average temperature to well below 2 °C above pre-industrial levels and to pursue efforts to limit the temperature increase to 1.5 °C above pre-industrial levels, recognizing that this would significantly reduce the risks and impacts of climate change;


(b) **Increasing the ability to adapt** to the adverse impacts of climate change and foster climate resilience and low greenhouse gas emissions development, in a manner that does not threaten food production;

(c) Making finance flows consistent with a pathway towards low greenhouse gas emissions and climate-resilient development.

2. This Agreement will be implemented to reflect equity and the principle of common but differentiated responsibilities and respective capabilities, in the light of different national circumstances.

#### **Tipping Points Related to 2°C-Guardrail**





## Paris Agreement Article 14. (Stocktaking)

1. The Conference of the Parties serving as the meeting of the Parties to the Paris Agreement shall periodically take stock of the implementation of this Agreement **to assess the collective progress** towards achieving the purpose of this Agreement and its long-term goals (referred to as the **"global stocktake").** It shall do so in a comprehensive and facilitative manner, considering mitigation, adaptation and the means of implementation and support, and in the light of equity and the best available science.

2. The Conference of the Parties serving as the meeting of the Parties to the Paris Agreement shall undertake its **first global stocktake in 2023 and every five years thereafter** unless otherwise decided by the Conference of the Parties serving as the meeting of the Parties to the Paris Agreement.

3. The outcome of the global stocktake **shall inform** Parties in updating and enhancing, in a nationally determined manner, their actions and support in accordance with the relevant provisions of this Agreement, as well as in enhancing international cooperation for climate action.

## **BRING HOME MESSAGE - 2**

- International legal bases are; UNFCCC (1992), Kyoto Protocol (1997) and Paris Agreement (2015).
- UNFCCC provides legal framework, including "ultimate objectives" and "common but differentiated responsibilities,
- Kyoto Protocol contains legal obligations only for developed countries ("Annex-I Parties") with specified mitigation commitments. ". Kyoto Flexibility Mechanisms are provided.
- Paris Agreement is applicable to all the Parties, and provides objectives (e.g., 1.5 2 degrees goal), aims to strengthen the global response to the threat of climate change, in the context of sustainable development and efforts to eradicate poverty. But there is no legal obligations of mitigation targets.

# After UNFCCC COP21 and Paris Agreement

- Partly thanks to the US-China's expressed positive positions, the Paris Agreement took effect before the COP22 (In Marrakech, 7<sup>th</sup> November 2016.)
- US Presidential election was held on Day-2 of COP22, but US' non-Federal bodies and industry representatives maintained their commitments to implement the Paris Agreement.
- At COP23 (in Bonn, 7<sup>th</sup> November 2017), US participated in technical discussions but there were strong presence of US "We are still in" group.

# DJT Administration

- On 1<sup>st</sup> June 2017, President Trump announced the US decision of withdrawal from the PA.

#### PA Article 28

1. At any time after three years from the date on which this Agreement has entered into force for a Party, that Party may withdraw from this Agreement by giving written notification to the Depositary.

2. Any such withdrawal shall take effect upon expiry of one year from the date of receipt by the Depositary of the notification of withdrawal, or on such later date as may be specified in the notification of withdrawal.

3. Any Party that withdraws from the Convention shall be considered as also having withdrawn from this Agreement.

# G-20 (in Hamburg, in July 2017)

Declaration of G-20 contains a paragraph specifically on US, which shows very clear contrast with the other positive actions of the other countries.

- "We take note of the decision of the United States of America to withdraw from the Paris Agreement. The United States of America announced it will immediately cease the implementation of its current nationally-determined contribution and affirms its strong commitment to an approach that lowers emissions while supporting economic growth and improving energy security needs."
- On 4<sup>th</sup> August, USA submitted a notification to the UN on its intention to withdraw from the Paris Agreement.

## **BRING HOME MESSAGE - 3**

- PA took effect within one year.
- However, new US Administration has decided to leave from PA (the withdrawal will take effect only in November 2020 under PA Article 28). Nonethess, US has concluded not to implement its own NDC.
- On the other hands, in June 2017, a coalition of US economic, education, and local government leaders announced they will continue to abide by the Paris agreement regardless of America's withdrawal, forming the We Are Still In movement. The coalition represents 120 million Americans and \$6.2 trillion of the US economy. In total, the group includes 125 cities, 9 states, 902 businesses and investors, and 183 colleges and universities.

# As for Japan,


- The level of ambition in INDC is perceived rather low.
- Since Japan does not participate in the KP Second Commitment Period (CP-2), Japan can not use KP Flexibility Mechanisms., including CDM. In this regard, a Joint Crediting Mechanism (JCM) is being implemented as bilaterally-agreed system. However, this may require clear recognition in terms of Paris Agreement Article 6.2.
- Japan's expansion of domestic coal-firing power stations and international support to developing countries might be subject to international criticism.

- 現在、京都議定書の第2次コミットメントには不参加。したがって、それに基づく国際的なマーケットメカニズムは使えない状況。京都メカニズとムと国際的な削減目標の設定は、炭素価格の決定の有効な手法の一つと考えられるが、それが十分に機能していない状況なのでは?
- JCM (Joint Crediting Mechanism)が国際的にどのように認知されるかは、なお、未 確定な面あり(パリ協定6条参照)。



PAの関連では、EUは、2030年までに40%、スイスは 2030年までに50%削減とのINDCを出している。日本は、 これらはもちろん、米国(2005年=>2025年で、26-28%) と比較しても非常に低いレベルの削減目標(2013年 =>2030年で、26%)を出しており、COP21の合意に則っ た INDC(NDC)の改善が必要ではないか?中期目標は、 2050年までの長期削減(80%削減(閣議決定))への過 程として考えていく必要があろう。最近の石炭火力の 増加は、国際的な批判の的になっている。



### Lack of Grid connectivity in Japan






#### **Electricity generation in Germany in 2018**







図 2:欧州の主要国における発電電力量に占める自然エネルギーの比率


